Erie County Legislator John Mills gave a report of what is going on in the County. He is working to keep the prison open. If there is tall grass at intersections of County roads and driveways you can call his office. New stadium should be enclosed by winter and the grass will be kept warm by natural gas and there will be approximately 200 events in the stadium.

Deputy Sheriff Brad Mohawk was in attendance explaining the task force why they are here and doing problem checks and quality of life calls, reporting they had 46 calls, 19 traffic stops and two accidents to investigate. They were at the library hot dog roast with car seat checks.

This meeting is to obtain the feelings of residents and will not be voted on tonight. Each person wishing to speak will get three minutes after giving their name and will address the board either for or against.

A number of residents spoke on the changing of the law, bringing in revenue and tax monies and people will come to purchase products

How will the land be preserved/taken care of as we do not know how they farm. One asked where this proposed location is and what about the impact on the highways and do they pay into social security, one person stated it would not be beneficial to the locals as this would not create jobs for

them. One would like to see a level playing field as they can underbid current businesses, wants fairness for all. They will be paying property taxes but many do not carry insurance. The zoning would be for everyone not just them. They would have to have workers compensation insurance. Supervisor Martin asked if anyone else wishes to speak. With no one wanting to speak the Public Hearing was closed at 8:35 PM.
