In the second round we received 4,000 masks with 750 shared with the Village of Gowanda for town residents. Supervisor Martin contacted Marilyn Calhoun and she does not know of any restrictions. The masks can be distributed to employees and town residents.

4. Discussion about loaning out of Tree with a Bank Account memorabilia (tree trunk slice)-Christopher Jeanniton of the Piece of Pie would like to display the tree trunk slab at his store. He measured it and the highway workers will move it. All agreed with a letter of the loan be done.

5. Discussion about senior trips subsidy – the Board received a report of what was done before the LKP and the 50+ Seniors group was turned over to the Town. (The 50+ group is a town group.) Supervisor Martin asks the Board to think this over and it will be discussed further.

6. Discussion on the Omni Navitas Community Solar Projects located at 12819 New Oregon Road, Collins, NY – A Special Use Permit application was submitted by Omni. The town was declared as lead agency. On January 8th Omni answered back so we had 20 days to act on a positive or negative declaration. We can have meeting on January 25th to do the declaration. from MDA said all is good under the agricultural impact: Beams are anchored into the ground; some concrete will be on site that will not disturb the soil and will be removed when the project has finished to its end. Cory McCandless asked for comments from the MDA letter. Ag and Markets wants land to be able to be returned back to farming. Attorney Musacchio suggests Erie County IDA draft a uniform PIOLT agreement for all and not leave individual communities to have to do their own. A PILOT is based on 1 - 3% of revenue (payment in-lieu of taxes). After the 30-day comment period a public hearing can be held. All neighbors adjacent to this property will need notification of the public hearing.

WHEREAS, the Collins Water District #1 had a substantial waterline break in the 6-inch water main along Route 62 early in the morning on December 25, 2020, and

WHEREAS, the break has been isolated and shut off since December 25, 2020 and needs to be repaired and brought back into service, and

WHEREAS, the Gowanda Water Department solicited bids for repair of the water main and received the following bids:

NOW THEREFORE BE IT RESOLVED that the Collins Town Board hereby authorizes Gallman Excavating, Inc to make repairs on the Water District #1 Route 62 water main in the amount of \$6,200.00 and that the expense be charged against budget line SW1-8397.200 Water Equipment and Capital Outlay, of the 2021 Collins Town Budget.

Resolution needed for Omni solar projects SEQR review – determination of significance – Derek Rule of MDA Engineers went through the Full Environmental Assessment Form Part 2 explaining whether no or small impact may occur or moderate to large impact may occur was checked off. Part 3 expanded on the answers of Part 2 and provided the reasons in support of the determination of significance. With what was identified Mr. Rule prepared a Positive Declaration on the project.

With this declaration, the contractor will have to identify the issues and send the town their additional steps of what they will do for the town to review. Cory McCandless stated a positive declaration on the process of ag farmland can take up to a year and is very costly. The landowner, Ronald Wittmeyer is aware the land would be taken out of the farmland protection agency. His family does not farm this land and if a positive declaration is approved, there is a chance this project will not continue. This property is prime agricultural land that falls in one of six categories on the Erie County Protection Plan and non-farm development should not appear in these areas. Omni is happy to explore a Community Benefit Agreement so as not to get the positive declaration. This would require a negative declaration and would be some sort of financial compensation and that money could be put to agricultural resources for the town. Omni will draft a proposal to the Town to review. If the Town Board and Omni both agree the time limit can be extended.

WHEREAS, the Board has examined and considered the Full Environmental Assessment Form (EAF) Part 1; caused to be prepared Part 2 and 3 of the EAF to evaluate potential significant adverse environmental impacts associated with the Proposed Action based on a review of the EAF Part 1, the application documentation, and its own independent analysis of the Proposed Action; and

WHEREAS, the Board has compared the potential environmental impacts of the Proposed Action, as set forth in Parts 2 and 3 of the EAF with the criteria for determining significance under 6 NYCRR 617.7(c).

NOW THEREFORE BE IT RESOLVED, that based upon the information contained in the EAF and associated documents, the Board, as Lead Agency for the Proposed Action contemplated herein, and after due deliberation, review and analysis of the Proposed Action and the criteria set forth in 6 NYCRR §617.7(c), hereby determines that the Proposed Action may have one or more significant adverse impacts on the environment including removing significant acreage of important agricultural soils at this project site from production for a substantial period of time and setting an undesirable precedent which will lead to comparable developmental pressures on other valued agricultural resources in the Town of Collins, contrary to important policies set forth in the Town of Collins/Village of Gowanda Master Plan, the Solar Energy Systems local law and the Erie County Farmland Protection Plan, resulting in a Positive Declaration determination of significance;

NOW THEREFORE BE IT RURTHER RESOLVED, THE Board directs the Applicant to prepare and submit the draft scoping document for the required Environmental Impact Statement (EIS) in accordance with 6NYCRR §617.8, within a period of thirty (30) days of this Positive Declaration; and

NOW HTEREFORE BE IT FURTHER RESOLVED, the Board directs to Town Clerk to publish the Positive Declaration in the Environmental Notice Bulletin pursuant to 6 NYCRR §617.12(c).

WHEREAS, in accordance with the provision of 6 NYCRR Part 617 (SEQR), the Board adopted a resolution on November 9, 2020, designating itself as Lead Agency for the proposed action pursuant to 6 NYCRR Part 617; and

WHEREAS, the Board has examined and considered the Full Environmental Assessment Form (EAF) Part 1; caused to be prepared Part 2 and 3 of the EAF to evaluate potential significant adverse environmental impacts associated with the Proposed Action based on a review of the EAF Part 1, the application documentation, and its own independent analysis of the Proposed Action; and

WHEREAS, the Board has compared the potential environmental impacts of the Proposed Action, as set forth in Parts 2 and 3 of the EAF with the criteria for determining significance under 6 NYCRR 617.7(c).

NOW THEREFORE BE IT RESOLVED, that based upon the information contained in the EAF and associated documents, the Board, as Lead Agency for the Proposed Action contemplated herein, and after due deliberation, review and analysis of the Proposed Action and the criteria set forth in 6 NYCRR §617.7(c), hereby determines that the Proposed Action may have one or more significant adverse impacts on the environment including removing significant acreage of important agricultural soils at this project site from production for a substantial period of time and setting an undesirable precedent which will lead to comparable developmental pressures on other valued agricultural resources in the Town of Collins, contrary to important policies set forth in the Town of Collins/Village of Gowanda Master Plan, the Solar Energy Systems local law and the Erie County Farmland Protection Plan, resulting in a Positive Declaration determination of significance;

NOW THEREFORE BE IT FURTHER RESOLVED, the Board directs the Applicant to prepare and submit the draft scoping document for the required Environmental Impact Statement (EIS) in accordance with 6NYCRR §617.8, within a period of thirty (30) days of the Positive Declaration; and

NOW THEREFORE BE IT FURTHER RESOLVED, the Board directs the Town Clerk to publish the Positive Declaration in the Environmental Notice Bulletin pursuant to 6 NYCRR §617.12(c).

Ms. McCandles asked the board to rescind the motion. Supervisor Martin asked if a Board member wants to. No response. If Omni waves the time period, both parties can negotiate. We can hold off posting the resolutions to the next meeting if we are going to negotiate the Community Benefit Agreement and then rescind the resolutions. But we need a written waiver notification from Omni that waives the time period of 20 days to the next meeting. She will talk with the financial team and make an offer to the Town.
