Presentation by Laura Landers of Freed Maxick CPA - 2018 Audit Report

The 2018 audit report materially represents the financial condition of the town. Ms. Landers went through the financial statement explaining what each statement represents. The overall condition of the fund balances are stable and the budgeting process is on target. The rest of the report are footnotes to the financial statement and does not reflect anything different from the past. All bank balances are fully collateralized. There were no audit adjustments and no significant weaknesses. Older outstanding payroll checks need to be sent to NYS as unclaimed funds. Ms. Landers thanked the bookkeeper, town clerk and the justices for all their help. Supervisor Martin thanked the bookkeeper for all her work on the audit.
