Pursuant to Section 108 of the Town law, the proposed salaries of the following town officials are hereby specified as follows:

1. Town Councilman \$7,754.12 each per annum, or \$31,016.47 in total
2. Supervisor \$42,069.99 per annum base amount, and an additional \$1,500.00 to supervise the Water Department, making the total \$43,569.99 per annum
3. Town Clerk \$50,771.17 per annum
4. Superintendent of Highways \$67,570.83 base amount, and an additional \$2,000.00 to supervise the Parks and Transfer Station, making the total \$69,570.83 per annum
