

RESOLUTION: AMEND RESOLUTION #101 OF 2025 - AGREEMENT TO SPEND HIGHWAY FUNDS PER §284 OF THE HIGHWAY LAWS

WHEREAS, in Resolution #101 of 2025 the Collins Town Board approved entering into a spending agreement with Highway Superintendent Chris Gerling per §284 of the Highway Law, and now wishes to make modifications to the Agreement.

NOW LET IT BE RESOLVED, that the Collins Town Board hereby approves entering into an amended agreement with Highway Superintendent Chris Gerling for 2025 to spend Town Highway Funds, per §284 of the Highway Law, as read, and authorize the Town Board members to sign the agreement.

RESOLUTION: APPROVE SIX MONTH EXTENSION TO THE TOWN'S MORATORIUM ON THE ISSUANCE OF APPLICATIONS AND GRANTING OF PERMITS FOR SITING OF COMMERCIAL SOLAR PANELS, WIND TURBINE AND BATTERY POWER PROJECTS IN THE TOWN OF COLLINS

WHEREAS, on December 9, 2024 the Collins Town Board adopted a six-month extension to the moratorium on utilities scale Solar, Wind Turbine and Battery Energy Storage Projects in the Town of Collins, and

WHEREAS, the Town Board desires to extend the moratorium for an additional six (6) months in order to finalize new Town codes that address the siting of the utilities scale Solar, Wind Turbine and Battery Energy Storage Projects in the Town of Collins.

NOW THEREFORE BE IT RESOLVED that the Collins Town Board hereby approves a six (6) month extension, to run from June 1, 2025 through November 30, 2025, of the moratorium on the issuance of applications and granting of permits for siting of commercial solar panel, wind turbine and battery power projects in the Town of Collins.
