Annual Drinking Water Quality Report for 2023 Town of Collins - WD 3 PO Box 420 Collins, New York 14034 (Public Water Supply ID# 1400430)

INTRODUCTION

To comply with State regulations, the Town of Collins will be annually issuing a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or other water quality standard. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water source is two groundwater wells; a 58 foot deep drilled well and a backup well which are located on Route 39. The water is disinfected with chlorine at the well house and iron is removed in green sand filters prior to distribution.

The New York State Department of Health (NYSDOH) has completed a source water assessment for the Town of Collins WD#3 water system, based on available information. Possible and actual threats to this drinking water source were evaluated. The state source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how easily contaminants can move through the subsurface to the wells. The susceptibility rating is an estimate of the potential for contamination of the source water. It does not mean that the water delivered to consumers is, or will become contaminated. See section "Are there contaminants in our drinking water?" for a list of the contaminants that have been detected.

The source water assessment has rated these wells as having a medium-high susceptibility to halogenated solvents, herbicides/pesticides, metals, nitrates, and other industrial organics and petroleum products. These ratings are due primarily to the assumption that the wells draw greater than 100 gallons per minute from an unconfined aquifer and since our water has somewhat high levels of iron. Also, the wells were rated as having a high susceptibility to enteric bacteria, enteric viruses, and protozoa. These ratings are due primarily to the assumption that the wells draw greater than 100 gallons per minute from an unconfined aquifer.

While the source water assessment rates our well(s) as being susceptible to microbial contamination, please note that our water is disinfected to ensure that the finished water delivered into your home meets New York State's drinking water standards for microbial contamination. A copy of the assessment, including a map of the assessment area, can be obtained by contacting us, as noted below.

ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include: total coliform, inorganic compounds, nitrate, lead and copper, volatile organic compounds, total trihalomethanes, haloacetic acids, and synthetic organic compounds. The table presented below depicts which compounds were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old.

It should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Notes:

1 - The level presented represents the 90th percentile of the 10 sites tested. A percentile is a value on a scale of

100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the lead values detected at your water system. In this case, 10 samples were collected at your water

system and the 90th percentile value for lead was the second highest value (3.41 ug/l). The action level for lead was not exceeded at any of the sites tested.

2 – The level presented represents the 90th percentile of the 10 sites tested. A percentile is a value on a scale of

100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the copper values detected at your water system. In this case, 10 samples were collected at your water system and the 90th percentile value for copper was the second highest value (0.16 mg/l). The action level for copper was not exceeded at any of the sites tested.

3 – The level represents the highest locational running annual average calculated from data collected.

Definitions:

<u>Maximum Contaminant Level (MCL)</u>: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.

<u>Maximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

<u>Maximum Residual Disinfectant Level (MRDL): The</u> highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

<u>Maximum Residual Disinfectant Level Goal (MRDLG)</u>: The level of a drinking water disinfectant below witch there is no known or expected risk to health. MRDLG's do not reflect the benefits of the use of disinfectants to control microbial contamination.

<u>Milligrams per liter (mg/l)</u>: Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm). <u>Micrograms per liter (ug/l)</u>: Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb). <u>N/A: Not Applicable</u>

Picocuries per liter (pCi/L): A measure of the radioactivity in water.

WHAT DOES THIS INFORMATION MEAN?

As you can see by the table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below the level allowed by the State.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants and young children. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. the Town of Collins is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 sec. to 2 min. before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

During 2022, our system was in compliance with applicable State drinking water operating, monitoring and reporting requirements with the exception of SOC monitoring incomplete due to SOC waiver not renewed.

Waivers3

Our water system is currently operating with a waiver from conducting asbestos sampling which expires on December 31, 2032. Our waiver from testing for bis-(2-ethyl-hexyl)-adipate, bis-(2-ethyl-hexyl)-phthalate and benzo-a-pyrene expired December 31, 2025. Your water system was issued a waiver ofrequired sampling for bis-(2- ethyl-hexyl)-adipate, bis-(2-ethyl-hexyl)-phthalate and benzo-a-pyrene (SOCS). This waiver expired on December 31, 2022 and needs to be renewed.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (800-426-4791).

WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life;
- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential fire-fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded. So get a run for your money and load it to capacity.
- Turn off the tap when brushing your teeth.
- Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it and you can save almost 6,000 gallons per year.
- Check your toilets for leaks by putting a few drops of food coloring in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.

CLOSING

Thank you for allowing us to continue to provide your family with quality drinking water this year.
