2. Diamond Maps presentation – Jason Opferbeck

Mr. Opferbeck's presentation showed what the program can do. The water hydrants, water lines, valves and parcel boundaries are all entered. The shut off valves are all GIS located. The system we now have is not working in all areas as some trees are blocking the telemetry. The new system will not use radios; it will go through the cloud.

The tank is now being operated manually each day. The first part of this system we have is from Cyclops and this next part will be purchased from them as a sole supplier of the equipment. Supervisor Tessmer wants a hard copy showing all valves, lines, etc.
