WHEREAS, the Collins Town Board supports the New York and Lake Erie Railroad's (NY&LE) grant application through the Passenger & Freight Rail Assistance Program (PFRAP) for the rehabilitation of approximately five miles of track between Cherry Creek and Conewango Valley, which is part of the Buffalo to Jamestown Rail Corridor and the Western New York Rail Initiative (WNYRI), that we believe is an integral part of the on-going efforts to promote tourism activity and maintain the line for future economic development along the corridor, and
