1. health insurance buyout program - a school system allows their employees who do not take the health insurance a buyout of \$1,250.00 per year. If this is passed, those that do not take the town insurance would have to fill out a form proving they have other insurance and the buyout would be divided by pay and would be taxable. The amount discussed was \$1,200.00.
