#### RESOLUTION: APPROVE TOWN CODE UPDATE SUPPLEMENT No. 2 WITH GENERAL CODE

WHEREAS, the Town Board wishes the Town Code to be up to date and include all recently adopted town laws, and

WHEREAS, General Code has submitted a proposal to Codify L. L. No. #2-2017, thereby supplementing the Town Code.

NOW THEREFORE LET IT BE RESOLVED, that the Collins Town Board Authorize General Code to Supplement the Town Code ( to Codify L. L. No. #2-2017) at a cost of between \$580 and \$670, that this expense be taken from the Town of Collins 2018 Budget Line A1989.400 and to authorize the Town Supervisor to sign the Supplement proposal with General Code.
